## **ODLUKU** **o popustu za parkiranje**

### **Član 1.**

Ovom Odlukom Društvo, omogućava potrošačima Tržnog centra Rajičeva i korisnicima parking garaže u sklopu Tržnog centra Rajičeva, **ostvarivanje prava na 3 (tri) sata besplatnog parkiranja pod uslovom da su putem jednog fiskalnog računa ostvarili kupovinu u Tržnom centru Rajičeva u iznosu od 6.000,00 dinara ili više.**

### **Član 2.**

**Potrošač i korisnik** parking garaže Tržnog centra Rajičeva u cilju ostvarenja prava na pogodnost iz čl. 1 ove Odluke **mora overiti račun sa iznosom od 6.000,00 dinara ili više na INFO Pultu Tržnog Centra Rajičeva na dan kupovine i korišćenja usluge parking garaže u Tržnom centru Radjičeva.**

### **Član 3.**

Redovna cena parkiranja, počev od 01.09.2024. godine, iznosi **300,00 RSD/1h** sa PDV-om, i naplaćuje se počev od prvog započetog sata.

### **Član 4.**

Ova Odluka stupa na snagu dana 01.09.2024. godine i zamenjuje sve ranije donate odluke o popustu za parkiranje.

### **Član 5.**

Ova Odluka je sačinjena u 2 (dva) istovetna primerka.

## **DECISION** **on parking discount**

### **Article 1**

By this Decision, the Company, provides customers of the Rajičeva Shopping Center and users of the parking garage within the Rajičeva Shopping Center to exercise **the right to 3 (three) hours of free parking, under condition that customers have made a purchase with one fiscal invoice within the Rajičeva Shopping Center in the amount of RSD 6,000.00 or more.**

### **Article 2**

**The customer and user** of the parking garage of the Rajičeva Shopping Center in order to exercise the right to benefit referred to in Art. 1 of this Decision **must certify the invoice in the amount of RSD 6,000.00 or more at the INFO Counter of the Rajičeva Shopping Center on the day of purchase and use of the parking garage service in the Rajičeva Shopping Center.**

### **Article 3**

The regular price of parking, starting as of 01.09.2024, is **300.00 RSD/1h** with VAT included, and is charged starting from the first started hour.

### **Article 4**

This Decision comes into effect on 01.09.2024 and replaces all previously adopted decisions on parking discounts.

### **Article 5**

This Decision is made in 2 (two) identical copies.
